CONFIDENTIALITY

- During the period of this Non-Disclosure Agreement, the student and the thesis supervisor shall not take advantage of or reveal such business or trade secrets of the host company/organization that have been entrusted to them or they have come to know in connection with the thesis work.
- The company/institution agrees to provide the necessary information so that the student is able to write the master thesis.
- Publication of the Master thesis is possible only with the permission of the host company/organization. If formally authorized, the publication of the Master thesis is nevertheless subject to the prior approval of the supervising professor.
- In case the Master thesis or parts of this Master thesis are employed for professional or commercial use, intellectual property of the work remains with the author, the rights of the University and its representatives are reserved.
- The student is obliged to follow the company's/organization's trade secrets, information communicated to him as well as information relating directly or indirectly to the activities of the company should be treated as strictly confidential, unless otherwise expressed by the company/organization.
- In case the company disagrees with the publication of the master thesis, only the academic part of the master thesis containing no confidential information is publishable.
- The student should be aware of the sections 321 and 162 of the Swiss Penal Code:
 - Article 321: Ch. 1 essentially states that those "who have revealed a secret they had learned during their studies, shall, upon complaint, be punished by imprisonment or fine. The revelation remains punishable even if the holder of the secret completed his studies."
 - Article 162: "One who has revealed a manufacturing secret or trade secret, who was required to keep it under legal or contractual obligation, who used this revelation to his own benefits, shall, upon complaint, be punished by imprisonment or fine."
- The professor (s) responsible for directing and/or evaluating the work is/are bound by official secrecy.
