

Data philanthropy

“In 2013, [...] the government of Côte d’Ivoire consented to the release of five months’ of anonymized mobile phone data. These data were then used to develop a model for containing the spread of epidemics. This kind of data philanthropy [...] – in which corporate entities or governments share anonymized information of potential public health significance – may provide new synergies between the for-profit sector and other stakeholders”



How to stimulate & incentivize IP philanthropy ?

Carrots and/or sticks ?



Stick



Compulsory licensing:

Grant of a license without consent
of the patent holder
(i.e. *forced/unvoluntary* license)

WTO TRIPS agreement (art. 31)
(«TRIPS flexibilities»)

Stick



Doha Declaration on the TRIPS Agreement
and public health (2001)
+ “Paragraph 6 System”

“We stress the importance we attach to
implementation and interpretation of the
[TRIPS Agreement] in a manner supportive of
public health, by promoting both access to
existing medicines and research and
development into new medicines”
