VISA PROCEDURE

The VISA process can take up to 5 months and needs to be initiated immediately upon receiving the acceptance letter.

CANCELLATION CONDITIONS

In the unlikely event that a prospective student cannot obtain a valid student VISA for Switzerland in spite of his best effort, the initial payment of CHF 10'000 is reimbursed in full. Students withdrawing from the programme by their own choice are not entitled to reimbursement.
