

The Diploma of Advanced Studies (**DAS**) has been created in collaboration with the Swiss Commodity Trading Association SUISSENÉGOCE (formerly the Swiss Trading and Shipping Association, STSA).

As of September 2022, participants can choose a shorter version of the program with the Certificate of Advanced Studies (**CAS**) in Commodity Trading, which is offered mainly online. This new program has been set up to answer the growing demand for online courses from our international audience.

The first week at the University of Geneva will allow professors, participants, Master in Trading students, and Alumni to interact.
