Dorothée Baumann-Pauly is a business ethics scholar with extensive practical experience working on the implementation of human rights in multi-stakeholder settings. Since 2013, she is the Director of Research at the NYU Stern Center for Business and Human Rights, managing its strategic, industry-specific research agenda. Since 2019, she directs the Geneva Center for Business and Human Rights at Geneva University's School for Economics and Management.

She has published widely on topics at the intersection of business ethics, corporate responsibility, private governance mechanisms and human rights and serves on the editorial board of the *Business and Human Rights Journal*. She is the author of *Managing Corporate Legitimacy* (Greenleaf 2013) and the co-editor of *Business and Human Rights – From Principles to Practice* (Routledge 2016), the first textbook on business and human rights.

Dorothée received a PhD in economics from the University of Zurich (Switzerland), an MA in Political Science from Rutgers University (USA) and an MA in Public Policy and Management from the University of Constance (Germany). She teaches business and human rights related subjects at HEC Lausanne, NYU Stern and other academic institutions in the US and Europe.

Florian Wettstein holds a PhD in business ethics from the University of St.Gallen. He is a past fellow of the Program on Human Rights and Justice at MIT and held previous faculty positions at York University (Toronto) and University of St. Thomas (Minneapolis/St. Paul).

Florian's research focuses predominantly on the intersection between business ethics and human rights. His article titled "CSR and the Debate on Business and Human Rights: Bridging the Great Divide" won the Business Ethics Quarterly best paper award in 2012. Florian is the author of "Multinational Corporations and Global Justice: Human Rights Obligations of a Quasi-Governmental Institution", published by Stanford University Press in 2009.

Florian is Vice-President of the International Society of Business, Economics, and Ethics (ISBEE) and of the Global Business and Human Rights Scholars Association (BR2R) as well as Editor-in-Chief of the *Business and Human Rights Journal (BHRJ)*, published by Cambridge University Press.

Berit Knaak received her Ph.D. in Management from the University of St.Gallen in 2020. During her studies, Berit spent one and a half years in Taiwan, where she studied the Mandarin language and culture at the National Chengchi University.

Berit worked as Research Associate at the Institute for Business Ethics at the University of St.Gallen and has been Fellow of the *Business and Human Rights Journal* since 2018. In her research, Berit focuses on the integration of human rights in companies and analyzes approaches that motivate companies to comply with human rights.

Christoph Good is Founding Partner of Good & Partner Rechtsanwälte (Zurich) and Senior Research Fellow at the Centre for Human Rights Studies of the University of Zurich (UZHR). Christoph studied law at the University of St.Gallen where he obtained his PhD with a study on the idea of human rights and humanitarian law in the works of Emer de Vattel (1714–1767). He is i.a. co-author of several reports on BHR topics by the Swiss Centre of Expertise in Human Rights [Baseline Study (2014) | CSR and Human Rights (2015) | Extraterritoriality (2016) | Access to Remedy (2018)] and published recently a GAP Analysis of the Swiss NAP (together with Twentyfifty).

Next to his practical work as a lawyer, he is a lecturer for International Law at the University of Zurich and works in an academic setting on the role of corporations in international law and the appearance of corporate human rights standards in the global governance discourse.


