THE CISA (SWISS CENTRE FOR AFFECTIVE SCIENCES) IS LOCATED AT THE CAMPUS BIOTECH, 9, CHEMIN DES MINES, 1202 GENEVA. AS ITS ACCESS IS RESTRICTED, WE WILL MEET AT 10.45 IN FRONT OF THE MAIN ENTRANCE AND WILL ENTER THE BUILDING ALL TOGETHER.

HOW TO REACH THE CISA WITH PUBLIC TRANSPORT FROM THE CORNAVIN TRAIN STATION:

THE CLOSEST TRAM/BUS STOPS ARE CALLED "FRANCE" (TRAM STOP) AND "MINES" (BUS STOP). THERE ARE TWO WAYS TO COME TO THE CENTER FROM THE CORNAVIN TRAIN STATION:

1. 1) TAKE BUS 25 OR 1 UNTIL THE STOP "MINES" (6TH STOP). THE BUS STOPS RIGHT IN FRONT OF THE MAIN ENTRANCE.
2. 2) TAKE TRAM 15 UNTIL THE STOP "FRANCE" (3RD STOP), WALK DOWNHILL FOR ABOUT 100 METERS (2 MINUTES), TOWARDS THE LAKE, THEN TURN LEFT ON "AVENUE BLANC". AT THE END OF THE STREET (ABOUT 300 METERS), YOU WILL REACH THE MAIN ENTRANCE OF THE BUILDING AT 9 CHEMIN DES MINES.
