





Free elective courses

- You have the possibility to take free elective courses for a maximum of 12 credits
- Recommended courses

"co-requis" courses

- Some students have "Co-requis" to complete in addition to the Master courses
- You must obtain the minimum grade of 4.00 for the "Co-requis" course by the August/September 2025 exam session at the latest
- These "Co-requis" courses count in the 12 credits that have to be obtained at the end of the 1st semester and in the 30 credits that have to be obtained the end of the second semester

Definition of ECTS Credits

1 ECTS Credit = 25 to 30 hours of workload

Credits are not a grades.

Grades of minimum 4.00 or «pass» secure the credits for a course

3 credits = 75 to 90 hours of workload


6 credits = 150 to 180 hours of workload

Registration (3)


- Register online for all the courses you are taking: including courses of "Co-requis", courses outside the Faculty
- Registration on Moodle is NOT sufficient and does not serve as an official registration
- Once the official deadline has passed, registration becomes final
- Print your registration to control it, and keep it as proof for the day of the exam

Registration (4)

- It is not possible to take an exam for the first time in the additional exam session (in August-September).
- The transcripts must be kept carefully: you are the only person to have the original transcripts.
- Grades of 4.00 or above secure the credits for that course
- Exams for which you have obtained at least 4.00 are definitively acquired.

Attempts

2 attempts for each compulsory exam : if you do not obtain the credits for the course in the ordinary exam session (January-February and May-June) you are automatically signed up to take the exam in the following additional exam session (August-September) of the same year.



Attempts – conditions of successful completion

- **Compulsory courses: Maximum 2 attempts**
 - 1 registration = 2 attempts during the year (art. 18 al. 3 et 22 al.1 e) RE SdS)
 - Compulsory courses
- **Elective courses/ Free elective courses: maximum 2x2 attempts**
 - 2 registrations = 2x2 attempts (art. 18 al.4 RE SdS) during a studies-deadline of 5 semesters
 - Elective courses, Free elective courses

Grading system

- Courses are assessed with grades that range from 0.00 to 6.00.
- Grades of **4.00/6** or above secure the credits for that course
- Grading is by $\frac{1}{4}$ point, for example : 3.75, 4.00, 4.25, 4.50...
- When you obtain the minimum grade of 4.00, you cannot retake the exam

Validation

- You have a provision of 12 credits that you can use to keep grades between 3.00 and 3.75 (art. 18 al.1 RE SdS)
- Fill in the [form](#) available in Secretariat des étudiants
- Any kept grade becomes the final grade
- Deadlines to keep grades (see [academic calendar](#))

Exams schedule

You will receive your exam schedule approximately 3 weeks before the start of the session on your [portail étudiant UNIGE](#)


Academic thesis or internship report

- Compulsory (24 credits), 2 attempts
- No online registration, the grade obtained will be recorded in the transcript following the communication of the result by director.
- The thesis can be defended in the 3 exams sessions, the August-September session can be the first attempt

Minimal requirements

- After the 1st semester of the 1st year, you must obtain at least 12 credits in the ordinary exam session; if not you will be eliminated from the Master's program (art 22 al.1 a) RE SdS)
- After the additional exam session at the end of the first year, you must obtain at least 30 credits; if not you will be eliminated from the Master's program (art. 22 al.1 b) RE SdS)
- After the 5th semester you must have obtained 90 credits (art 22 al.1 h) RE SdS)
- Part-time possible (on request)

Minimal requirements(2)



Mobility project

- The mobility can begin (with restrictions) in the second semester for the 90-credits Masters
- The mobility cannot exceed 1 semester and 30 credits maximum
- Your UNIGE transcript only shows the titles of the Geneva courses, and no grades. It is indicated "Equiv"
- The courses taken in mobility do not enter into the calculation of the general average
