During my years as research and teaching assistant and as research and teaching fellow (Neuchâtel and Zurich, 1986-1997), I regularly offered seminars in methodology (historical-critical reading of the New Testament texts), workshops in Greek reading, and others. Since my nomination as full professor in New Testament studies at the University of Neuchâtel in 1997, I have taught almost every semester at all levels (bachelor, master and doctoral programs; CAS; MAS; continuing education), on multiple texts and subjects (Johannine literature, Pauline literature, archeology of ancient Galilee, historical Jesus, parables in the synoptic tradition, the Q-hypothesis, NT anthropology, resurrection in second-Temple Judaism and early Christianity, the notion of love in early Christian traditions, etc.) applying various didactic (notably regular e-learning teaching since 2004) and methodological approaches (essentially a classical historical-critical approach, but also integrating tools from narratology, social sciences, cultural anthropology, sociology of knowledge, and philosophical and theological hermeneutics).

# Major scientific achievements during 2016-2020

My main research work during 2016-2020 focused on the following three areas, namely the so-called deuteropauline literature, the Gospel of John, and the historical Jesus.

(1) The deuteropauline literature began to attract my attention as soon as I finished my thesis project in 1994. It consists of several letters within the Pauline corpus of the New Testament which, according to a certain consensus in the specialized literature, were not written, or at least dictated, by the apostle Paul in the middle of the first century CE, but which date back to a later period, written by people belonging to the Pauline milieu and familiar with his thought. On closer inspection, the existence of these pseudonymous writings, calling upon the name of Paul as a figure of authority of the past in order to continue his thinking in new historical contexts, certainly constitutes a very interesting phenomenon of reception, but also raises many questions: what about the existence and perception of pseudepigraphy in the context of Greco-Roman antiquity? What

about the reasons for the production of such literature? What about its rhetorical and argumentative strategies? and others. In my research, I have concentrated on the *letters to the Colossians and Ephesians*, and occasionally on 2 Thessalonians and the so-called pastoral epistles. Since the 1990s, I have published several articles in French, German and English in order to better grasp this problem. At two international conferences in October 2016 (Geneva and Lausanne Universities) and in April 2017 (Humboldt University in Berlin), organized jointly with two colleagues from Berlin and Lausanne – prof. Simon Butticaz and Jens Schröter –, we brought together about thirty scholars to deal with numerous aspects related to the receptions – plural, and sometimes even contradictory – of Paul and his thought during the first two centuries of ancient Christianity. This work resulted in a voluminous publication in 2018 (*Receptions of Paul in Early Christianity*, de Gruyter). As for my work on Colossians and Ephesians in particular, my methodological approach is that of the historical-critical method, with a strong emphasis on the analysis of semantic, text-pragmatical and rhetorical procedures. For some years now, I have also been trying to integrate work from theories of collective memory, the sociology of space and the sociology of knowledge. My project of a *scientific commentary on the letter to the Colossians* will be the culmination of this fascinating line of research.

- (2) The Gospel of John was my first area of research as a young doctoral student. After the publication of my doctoral thesis on the Johannine farewell discourses published in German in 1995 by Vandenhoeck & Ruprecht (Göttingen) –, I continued at various points to work on this corpus. During the period 2016-2020, I published a study on the understanding of the Spirit in the Gospel of John and completed another on the understanding of the Johannine miracle narratives as "signs" (expected to be published in a volume at Mohr Siebeck (Tübingen).
- (3) Research on the historical Jesus has been, since the advent of the historical-critical approach to religious traditions in the 18<sup>th</sup> century, a privileged and intensely discussed field of research in studies on the New Testament and early Christianity. For some years now, I have also been engaged in this debate, trying to familiarize a French-speaking public, often poorly informed, with the current state of specialized research. Thus, in the spring semester of 2016, I organized a cycle of ten public lectures on the question of the historical Jesus, inviting recognized specialists from several European countries to speak at the University of Geneva. The conference cycle met an unexpected success. The contributions were published in 2017 under the title Jésus de Nazareth. Études contemporaines (Geneva). I then encouraged Labor et Fides to translate Jens Schröter's important book on the same subject into French (Jésus de Nazareth. À la recherche de l'homme de Nazareth, 2018). At the same time, I spoke about the historical investigation of Jesus in different university and para-university contexts, among others during a research seminar on June 14, 2019 at the University of Lorraine (Metz, France).
